PRESS NOTE

COMBINED STENOGRAPHERS' (GRADE 'B'/GRADE 'I') LIMITED DEPARTMENTAL COMPETITIVE EXAMINATION, 2019, 2020 & 2021

The written examination of the Combined Stenographers' (Grade 'B'/Grade 'I') Limited Departmental Competitive Examination, 2019, 2020 and 2021 was held, by the Union Public Service Commission on 13th and 14th December, 2025, for addition to the Select Lists of the Private Secretary of the services. Subsequently, a qualifying shorthand test was conducted, by the Commission, on 20th, 27th & 28th December, 2025. The candidates, with the under mentioned roll numbers, have qualified, **for the year 2020**, for the next part(Part-II) of the examination, i.e. for evaluation of their records of service.

2. The candidature of all these candidates is purely **"PROVISIONAL"** and subject to review at subsequent stages of the examination. If at any stage of the examination process, any candidate is found to be ineligible for the examination, his/her candidature is liable to be cancelled.

3. The mark-sheets of the candidates will be uploaded on the Commission's website within 15 days from the date of publication of the final result for the year 2021 w.r.t. the Combined Stenographers' (Grade 'B'/Grade 'I') Limited Departmental Competitive Examination, 2019, 2020 and 2021 and will remain available on the website for a period of 30 days thereafter.

4. The result of the first part (Part-I), for the year 2020, in relation to the Combined Stenographers' (Grade 'B'/Grade 'I') Limited Departmental Competitive Examination, 2019, 2020 and 2021, is declared in accordance with the Rules for the aforesaid examination and the relevant instructions.

5. The final selection of the candidates, including the candidates belonging to the Scheduled Castes and the Scheduled Tribes, for inclusion in the Select List for each category, will be decided in terms of the instructions issued by Department of Personnel & Training vide O.M. No. 36012/16/2019-Estt.(Res.) dated 12.04.2022 and will be subject to the final outcome of the Civil Appeal No. 629 of 2022 arising out of SLP (C) No. 30621/2011.

6. The final selection of the PwBDs candidates, for inclusion in the Select List, for the year 2020, for each category, will be decided on the basis of the instructions issued by Department of Personnel & Training vide O.M. No. 36012/01/2020-Estt.(Res.II) dated 17.05.2022.

7. The result in respect of Category-IV (Private Secretary of CSSS) is subject to outcome of the following matters presently sub-judice before the Hon'ble Central Administrative Tribunal, Principal Bench, New Delhi:-

- (i) O.A. No. 3801 of 2025 in the matter of Mahaveer Prasad Gupta & Ors. Vs Union of India & Anr.;
- (ii) O.A. No. 3828 of 2025 in the matter of Som Dutt & Ors. Vs Union of India & Ors.;
- (iii) O.A. No. 3863 of 2025 in the matter of Hemant Kumar & Ors. Vs Union of India & Ors.; and,
- (iv) O.A. No. 3923 of 2025 in the matter of Vipin Kumar & Ors. Vs Union of India & Ors..
